## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of May 26, 2017 by **SILICON VALLEY BANK** (the "*Assignee*"), in favor of **O'REILLY MEDIA, INC.**, a Delaware corporation ("*O'Reilly*"), and **SAFARI BOOKS ONLINE, LLC**, a Delaware limited liability company ("*Safari*", and together with O'Reilly, each individually, a "*Grantor*", and collectively, the "*Grantors*").

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


