TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is effective as of February 16, 2017 ("Effective Date") and is entered by and between Marksmen, Inc., a Delaware corporation with its principal place of business located at 111 North Maryland Avenue, Suite 201, Glendale, CA 91206 ("Assignor"), in favor of Microsoft Corporation, a Washington corporation with its principal place of business located at One Microsoft Way, Redmond WA 98052 ("Assignee"), with reference to the following facts and circumstances:

WHEREAS, as of February 16, 2017, Assignor was the owner of all right, title and interest in the MYXER trademark, including the appurtenant goodwill associated therewith and U.S. Registration No. 3,365,947 (the "Trademark"); and

WHEREAS, on February 16, 2017, subsequent to the acquisition of the Trademark by Assignor, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Assignee acquired all of Assignor's right, title and interest in and to the Trademark; and

WHEREAS, Assignee is the owner in fact of the Trademark, and the Parties desire to reflect these facts on the records of the United States Patent and Trademark Office;

NOW, THEREFORE, Assignor and Assignee hereby agree as follows:

1. Assignment of Trademark. Assignor transfers, conveys, assigns and delivers to Assignee as of the Effective Date all of Assignor's right, title and interest and associated goodwill, including all of Assignor's common law and statutory right, title and interest in and to the Trademark, all of Assignor's rights of registration, maintenance, renewal and protection thereof, and all rights of recovery and of legal action for past infringements and of opposition, interference and/or cancellation proceedings for protection of the Trademark, and all products, proceeds and revenues arising from or relating to any and all of the foregoing. Assignor agrees to provide all assistance reasonably requested by Assignee in the establishment and recordation of Assignee's rights in and to the Trademarks.
