
NOW THEREFORE, for good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, Assignor hereby, without reservation:

2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States to issue or transfer the Trademark to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.
