("Release"), dated as of the 26 day of May 2017, by JPMORGAN CHASE BANK, N.A., a National Banking Association ("JPMCB"), having an office at 270 Park Avenue, 41st Floor, New York, NY 10017 and BLUE MAN GROUP PRODUCTIONS, LLC, a Delaware limited liability company ("BMGP"), having its principal executive offices at 599 Broadway, 6th Floor, New York, NY 10012.

WITNESSETH:

WHEREAS, pursuant to the parties' November 30, 2012 Trademark Security Agreement ("Security Agreement"), BMGP granted to JPMCB Security Interests ("Security Interests") in certain collateral as defined in said Trademark Security Agreement, including the U.S. trademark applications and registrations listed in Exhibit A ("Trademarks") hereto:

WHEREAS, the Security Interests were recorded in the United States Patent and Trademark Office at reel/frame 004913/0886; and

WHEREAS, BMGP and JPMCB have agreed to retire the parties' obligations under the Security Agreement and JPMCB wishes to release its Security Interests in the U.S. trademark applications and registrations listed in Exhibit A hereto;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. JPMCB hereby releases its Security Interests and any right, title and interest which it may have in and to all Trademarks listed on Exhibit A hereto, does

hereby release and terminate all liens and security interests in and to the Trademark collateral which were granted, pledged and assigned to JPMCB, including the right to sue for past, present and future infringements thereof.






