2. The name of the entity immediately after the conversion shall be Tecumseh Products Company LLC, a Michigan limited liability company.
3. The surviving entity will be governed by the Michigan Limited Liability Act.
4. The address of the registered office of the surviving entity in the State of Michigan shall be 40600 Ann Arbor Road East, Suite 201, Plymouth, MI 48170.
5. The street address and the address of the principal place of business for the surviving entity is 5683 Hines Drive, Ann Arbor, MI 48108.
6. Immediately prior to conversion, the entity has 1,000 shares of common stock outstanding (the "Common Shares"). The Common Shares are entitled to vote.
7. Immediately on the conversion, each issued and outstanding Common Share shall be converted into one unit of membership interest in Tecumseh Products Company LLC.
8. The conversion is effective on November 23, 2016.
9. The plan of conversion will be furnished by the surviving business organization, on request and without cost, to any shareholder or member of the converting corporation. The conversion is permitted by the law that will govern the internal affairs of the business organization after conversion and the surviving business organization complies with that law in converting.

OF
