## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of May 26, 2017 by **SILICON VALLEY BANK**, as Administrative Agent (the "*Assignee*"), in favor of **KASEYA LIMITED**, an Irish private company (the "*Grantor*").

**WHEREAS**, Grantor executed and delivered a Trademark Security Agreement dated as of July 11, 2014, granting Assignee a security interest in all of its "Trademarks" as defined therein (collectively, the "*Marks*"), which was recorded with the Assignment Division of the United States Patent and Trademark Office ("*USPTO*") on July 14, 2014, at Reel 5321, Frame 0786;

**WHEREAS**, Grantor has requested that Assignee hereby terminate, release, and discharge fully its security interests in all right, title and interest of Grantor in, to and under each Grantor's Marks, including, without limitation, the Marks identified in **Exhibit A** hereto; and

**WHEREAS**, Grantor has requested that Assignee provide a document suitable for recording in the USPTO to evidence the release of its security interests in the Marks as herein provided.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignee hereby:

1. terminates, releases, and discharges all security interests in Grantor's right, title and interest in, to and under the Marks, and all goodwill associated therewith, including, without limitation those Marks identified in **Exhibit A** hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO and such other governmental agencies anywhere in the world where Assignee registered or recorded any security interest in Marks; and
3. agrees that it shall, at Grantor's sole cost and expense, and at Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to such Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
