RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of May 31, 2017 (this “Release”) is made by SUNTRUST BANK, as administrative agent (in such capacity, together with its successors and permitted assigns, the “Administrative Agent”) for the Secured Parties (as defined in the Guaranty and Security Agreement referred to below) in favor of IRONPLANET, INC., a Delaware corporation (the “Grantor”).

Pursuant to the Guaranty and Security Agreement, dated as of September 16, 2015 entered into by IronPlanet, Inc., Administrative Agent, and others party thereto (as amended, restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), Grantor and Administrative Agent entered into a certain Trademark Security Agreement, dated as of September 16, 2015 and recorded in the United States Patent and Trademark Office on September 17, 2015, at Reel 5625, Frame 0294 (the “IP Security Agreement”), and pursuant to the Guaranty and Security Agreement and IP Security Agreement, Grantor mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (as defined in the IP Security Agreement), including the foregoing identified on Schedule A hereto and incorporated herein by reference.

2.

The Administrative Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the mortgage, pledge and hypothecation in and all of its Lien on and security interest in, all right, title and interest in, to and under the Trademark Collateral granted under the Guaranty and Security Agreement and IP Security Agreement. Any right, title or interest of the Administrative Agent in such Trademark Collateral shall hereby cease and become void. This Release does not terminate, release or discharge the Administrative Agent’s security interest in any intellectual property or any other asset of the Grantor other than the Trademark Collateral.

3.

The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary and requested by Grantor to effect the release of the security interest contemplated hereby, at Grantor’s expense.
