RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the “Release”) is made as of May 31, 2017, by **THE CIT GROUP/BUSINESS CREDIT, INC.** (successor by merger with **THE CIT GROUP/CREDIT FINANCE, INC.**) (“CIT”), in favor of **TRILLIANT FOOD AND NUTRITION, LLC** (the “Grantor”).

W I T N E S S E T H

WHEREAS, Trade-mark Coffee Corporation (“TCC”) granted to CIT a security interest in and to the registered U.S. trademarks identified on Schedule 1 attached hereto (collectively, the “Trademark Collateral”);

WHEREAS, such security interest was recorded with the U.S. Patent and Trademark Office (“USPTO”) on July 10, 1996 at Reel 1480, Frame 0256;

WHEREAS, TCC assigned its entire interest in the Trademark Collateral to the Grantor, which such assignment was recorded with the USPTO on July 24, 2015;

WHEREAS, the Grantor requests from CIT a specific release of the security interest granted and recorded against the Trademark Collateral; and


WHEREAS, CIT has agreed to grant to the Grantor a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration previously tendered by TCC, as prior owner of the Trademark Collateral, the receipt and sufficiency of which are hereby acknowledged, CIT does hereby assign, terminate, release and discharge the entirety of the security interest in the Trademark Collateral and reassigns to the Grantor, without any recourse and without any representations or warranties of any nature, express or implied, any and all right, title and interest of any nature whatsoever which it may hold in or to the Trademark Collateral and associated common law rights and goodwill appurtenant thereto, and further agrees that it shall execute all other documents and do all other acts reasonably necessary to relinquish, confirm, effectuate and record this Release and the Grantor’s right, title and interest in and to the Trademark Collateral.
