RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

WHEREAS, by a certain Pledge and Security Agreement dated as of February 14, 2012, and Supplement No. 1 thereto dated as of January 26, 2015, and a Supplement No. 2 thereto dated as of October 28, 2016 (the "Agreement"), by Axon Downhole Products Inc., an Alberta corporation (the "Grantor") to Wells Fargo Bank, National Association, a national banking association, in its capacity as administrative agent ("Wells Fargo"), which Agreement was recorded with the United States Patent and Trademark Office on June 28, 2016, at Reel 039186 and Frame 0730, on June 28, 2016, at Reel 039028, Frame 0282, and on November 11, 2016, at Reel 040597 and Frame 0285, the Grantor granted to Wells Fargo a security interest in and lien on those patents and patent applications and trademarks owned by the Grantor and set forth on Exhibit A hereto;

WHEREAS, Wells Fargo desires to release its security interest in and lien on the patents and patent applications and trademarks set forth on Exhibit A hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Wells Fargo hereby states as follows:

1. Definition. The term "Patent and Trademark Collateral", as used herein, shall mean all of Grantor's right, title and interest in the following (collectively, the "Patent and Trademark Collateral")

- a. all of Grantor's right, title and interest in and to patents or applications for patent, fees or royalties with respect to each, and including without limitation the right to sue for past infringement and damages therefor, and licenses thereunder, listed on Exhibit A hereto (the "Patents"); and
- b. all of the Grantor's right, title and interest in and to trademarks, service marks, collective membership marks, registrations and applications for registration for each, and the respective good will associated with each, and including without limitation the right to sue for past infringement and damages therefor, and licenses thereunder, listed on Exhibit A hereto (the "Trademarks").

2. Release of Security Interest. Wells Fargo, on behalf of itself and its successors, legal representatives and assigns, does hereby terminate, release and discharge its security interest in and lien on the Patent and Trademark Collateral hereto and reassigns to Grantor all right, title and interest of Wells Fargo in the Patent and Trademark Collateral.

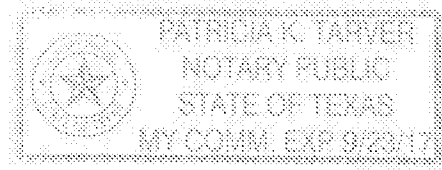
