TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT AGREEMENT (this "*Agreement*") is made as of the 31st day of May, 2017 by and between SYNGENTA CORPORATION, a corporation organized and existing under the laws of the United States, and Syngenta Participations AG, a corporation organized and existing under the laws of Switzerland.

WHEREAS, SYNGENTA CORPORATION is the owner of the Trademark and trademark rights of record in the United States Trademark Office set forth on Exhibit I hereto and all goodwill associated therewith; and

WHEREAS, SYNGENTA CORPORATION desires to assign to Syngenta Participations AG, and Syngenta Participations AG desires to accept from SYNGENTA CORPORATION, ownership of the Transferred Trademark.

NOW, THEREFORE, SYNGENTA CORPORATION does hereby assign, sell and transfer unto Syngenta, its successors and assigns, for good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the entire and exclusive right, title and interest in and to the Transferred Trademark, together with the goodwill of the business symbolized by the Transferred Trademark, any registrations therefor, and the right to sue for past, present or future infringements or dilution thereof and to recover damages and obtain all other remedies in respect to any such infringements or dilution thereof. This Assignment may be recorded with any governmental agency in order to perfect the ownership interest of Syngenta.
