RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated May 31, 2017 by BMO HARRIS BANK N.A., a national banking association formerly known as Harris N.A. ("*BMO Harris*"), with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, acting as administrative agent hereunder for the Secured Creditors as defined in the Agreement referred to below (BMO Harris, acting in its capacity as such administrative agent being hereinafter referred to as the "*Agent*");

WITNESSETH:

WHEREAS, American Traffic Solutions, Inc., a Kansas corporation ("*Debtor*"), with its mailing address at 7681 E. Gray Road, Scottsdale, Arizona 85260, and Agent were parties to a certain Trademark Collateral Agreement dated July 31, 2009 between Debtor and Agent which was recorded in the United States Patent and Trademark Office on August 4, 2009 at Reel 004036, Frame 0915 (the "*Agreement*"), pursuant to which Debtor granted to Agent, a security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademark Property*"); and

Agent hereby releases its security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any arising under the Agreement, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:

(i) each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.
