TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of May 31, 2017 by **SILICON VALLEY BANK** (the "*Bank*"), in favor of **MEDIAMATH, INC.**, a Delaware corporation ("*Grantor*").

WHEREAS, the Grantor executed and delivered an Amended and Restated Intellectual Property Security Agreement, dated as of December 14, 2009 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Agreement*"), granting the Bank a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the Assignment Division of the United States Patent and Trademark Office ("*USPTO*") on July 26, 2011, at Reel 4590, Frame 0704;

WHEREAS, the Grantor executed and delivered a First Amendment to Amended and Restated Intellectual Property Security Agreement effective as of June 14, 2010 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*First Amendment*"), granting the Bank a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the USPTO on July 26, 2011, at Reel 4590, Frame 0757;

WHEREAS, the Grantor executed and delivered a Second Amendment to Amended and Restated Intellectual Property Security Agreement effective as of July 15, 2011 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Second Amendment*"), granting the Bank a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the USPTO on July 26, 2011, at Reel 4590, Frame 0818;

WHEREAS, the Grantor executed and delivered a Supplement to Amended and Restated Intellectual Property Security Agreement dated as of September 23, 2013 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Supplement*", together with the Agreement, First Amendment and Second Amendment, collectively, the "*Grant*"), granting the Bank a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the USPTO on September 24, 2013, at Reel 5122, Frame 0593;

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor's in, to and under all of the trademarks and trademark applications described in the Grant (collectively, the "*Trademarks*") as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording in the USPTO to evidence the release of the Administrative Agent's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in each Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
