**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of June 2, 2017 (this "Release"), is made by KeyBank National Association, as administrative agent (in such capacity, the "Agent"), in favor of National Spine and Pain Centers Holdings LLC, a Delaware limited liability company ("Holdings"), as follows:


