Now, therefore, for good and valuable consideration provided to Assignee by Assignor, Assignee, by these presents, does (a) release, without warranty or recourse, Assignor from Assignee's security interest in the entire right, title and interest in and to the Trademarks, (b) reassigns, grants and otherwise reconveys to Assignor, without warranty or recourse, all of its right, title and interest in and to the Trademarks and (c) waives and relinquishes all of its rights, powers, privileges and remedies with respect to the Trademarks.

Assignor, or its designee, may record this Release of Security Interest in Trademarks in the U.S. Patent and Trademark Office and in any other offices as may be necessary to carry out the intention of this Release of Security Interest in Trademarks, and to the extent applicable, Assignee authorizes and requests that the U.S. Patent and Trademark Office record this Release of Security Interest in Trademarks.
