
NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

IN WITNESS WHEREOF, Assignor and Assignee have executed this Confirmatory Trademark Assignment below.


