**TERMINATION AND RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

May 17, 2017

WHEREAS, DISA Industries, Inc. an Illinois corporation (herein referred to as the "Grantor") has, in connection with that certain Senior Facilities Agreement, dated as of February 24, 2015 (as from time to time amended, modified or supplemented, the "Senior Facilities Agreement"), among Grantor, the other parties thereto and Nordea Danmark, Filial af Nordea Bank AB (publ), Sverige (formerly Nordea Bank Danmark A/S), as agent, entered into (i) a Security Agreement, dated as of September 28, 2015 (as from time to time amended, modified or supplemented, the "Security Agreement") by the Grantor and the other parties thereto in favor of Nordea Danmark, Filial af Nordea Bank AB (publ), Sverige (formerly Nordea Bank Danmark A/S), as Security Agent (in such capacity, the "Security Agent") and (ii) an Intellectual Property Security Agreement Supplement, dated as of September 28, 2015 (as from time to time amended, modified or supplemented, the "IP Supplement" and, together with the Security Agreement, the "Agreements") by the Grantor in favor of the Security Agent, pursuant to which Agreements the Grantor granted a security interest (the "Security Interest") in all of the Grantor's right, title and interest in and to the Intellectual Property Collateral (as defined in the IP Supplement), including without limitation the copyrights/trademarks/patents set forth on the attached Schedule A (the "Scheduled IP"), all to the extent set forth in the Agreements;

WHEREAS, the IP Supplement was recorded in the U.S. Patent and Trademark Office on September 29, 2015 at Reel 5632, Frame 0166; and

WHEREAS, the Grantor desires to transfer the Scheduled IP and such transfer is permitted under the terms of Senior Facilities Agreement and the Agreements, and the Security Agent, on behalf of itself and the other Secured Parties (as defined in the Senior Facilities Agreement) desires to release the Security Interest in the Intellectual Property Collateral.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Security Agent hereby, on behalf of itself and the other Secured Parties, releases the Intellectual Property Collateral in the Scheduled IP, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Agreements with respect to the Scheduled IP, (ii) assigns, conveys, transfers and sets over to the Grantor any right, title or interest that the Security Agent may have acquired and re-vests in the Grantor the full unencumbered title to the Scheduled IP and the goodwill associated therewith, and (iii) releases the Grantor from all covenants, obligations, liabilities and warranties under the Agreements related to the Scheduled IP.
