

WHEREAS, Assignee is the successor to the portion of Assignor's business to which the Marks pertain;



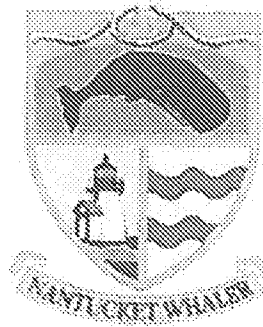


