SERVICE MARK PURCHASE AND ASSIGNMENT AGREEMENT
FOR ACCLARASM

This Service Mark Purchase and Assignment Agreement (the "Agreement") is made as of March 17, 2017, (the "Effective Date"), between Acclara Solutions Group, LLC, (the "Assignor"), and Acclara Solutions, LLC, (the "Assignee").

The Assignor is the owner of a mark, ACCLARASM (the "Service Mark"), that is allowed by the USPTO as of March 7, 2017, U.S. Serial No. 87132122 (Docket/Reference 38722-6000US).

The Assignee wishes to acquire the Assignor's rights in the Service Mark listed in this Agreement.

The Assignee agrees to pay the Assignor \$100.

In exchange, the Assignor hereby conveys, transfers, and assigns to the Assignee all of the Assignor's right, title, and interest of whatever kind in the Mark, together with:

- 1) the goodwill of the business relating to the products and services on which the Mark is used and for which registration of the Mark has been applied for,
- 2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Mark, including without limitation, damages, and payments for past or future infringements and misappropriations of the Mark, and
- 3) all rights to sue for past, present and future infringement or misappropriations of the Mark.

The Assignor further covenants that it will take all actions that may be necessary for securing, completing, or vesting in the Assignee full right, title, and interest in the Mark and its related property.
