THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT ("Release") is made as of this 12th day of April, 2017, by MIDCAP FUNDING IV TRUST (successor-by-assignment to MidCap Financial Trust), in its capacity as administrative agent ("Agent"), in favor of PRIORITY AMBULANCE HOLDINGS, LLC, a Delaware limited liability company ("Company").
