NOTICE OF RELEASE OF
SECURITY INTEREST IN TRADEMARKS

June 6, 2017

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of July 2, 2014 (the "IP Security Agreement"), MPS Chicago, Inc., an Illinois corporation (f/k/a Jet Lithocolor, Inc.) (the "Grantor") assigned and granted to Barclays Bank PLC, as Collateral Agent (the "Collateral Agent"), a security interest in the Grantor's right, title and interest in and to the applicable trademarks listed on Schedule I hereto (the "Trademark Collateral");

WHEREAS, pursuant to the Payoff Letter, dated as of June 6, 2017, by and among the Collateral Agent and Multi Packaging Solutions Limited, a limited liability company incorporated under the laws of England and Wales (the "UK Borrower"), MPS/CSK Holdings, Inc., a Delaware corporation ("MPS/CSK Holdings"), Multi Packaging Solutions, Inc., a Delaware corporation ("MPS"), and MPS Mustang Corp., a Delaware corporation ("MPS Mustang" and together with the UK Borrower, MPS/CSK Holdings and MPS, the "Borrowers"), the Borrowers have requested and the Collateral Agent has agreed to procure, execute and deliver to the Borrowers, at the expense of the Borrowers, such documents confirming and carrying out the release and discharge of the Secured Parties' security interest in the Trademark Collateral; and


NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent does hereby agree as follows:

1. Release. As of the date listed on the signature page hereto, the Collateral Agent hereby releases and discharges its security interest in the Trademark Collateral.
2. Further Assurances. The Collateral Agent hereby agrees, at the Borrowers' expense, to execute such instruments and to take such other actions as the Borrowers may reasonably request to terminate the Collateral Agent's security interest in the relevant Trademark Collateral.
3. Governing Law. This Notice of Release of Security Interest in Trademarks shall be governed by and construed and interpreted in accordance with the laws of the State of New York.
4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the IP Security Agreement.
