**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL** (this "**Release**"), dated as of June 1, 2017, is made by HEALTHCARE FINANCIAL SOLUTIONS, LLC, as successor agent to General Electric Capital Corporation, in its capacity as Administrative Agent and Collateral Agent for the Lenders and Secured Parties (the "**Agent**"), under the Credit Agreement referred to below (terms used in this Release and not herein defined shall have the meanings set forth in the Credit Agreement).

**WHEREAS**, in connection with that certain Credit Agreement dated as of July 29, 2010 (as amended and restated on September 26, 2013 and as further amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "**Credit Agreement**"), by and among GeoDigm Corporation, as Borrower, the other Loan Parties from time to time party thereto, the Lenders and L/C Issuers from time to time party thereto and Agent, the Lenders have severally agreed to make extensions of credit to the Borrower;

**WHEREAS**, in connection with the Credit Agreement and together with all general security agreements, trademark security agreements, patent security agreements, reaffirmations of trademark security agreements and reaffirmations of patent security agreements entered into in connection therewith, and pursuant to those certain agreements described on Annex I attached hereto (collectively, the "**Security Agreements**"), the Borrower and certain of the other Loan Parties (together with the Borrower, the "**Grantors**") granted security interests in the intellectual property owned by Grantors, including those listed on Annex I attached hereto (the "**Intellectual Property Collateral**"); and

**WHEREAS**, the Security Agreements were recorded in the United States Patent and Trademark Office (the "**USPTO**") on the dates and on the reels and frames set forth on Annex I hereto.

**NOW THEREFORE**, in consideration of the material covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby RELEASES, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its Lien on and security interest in, and right of setoff against, the Intellectual Property Collateral, whether granted pursuant to the Security Agreements or any other agreement or document delivered in connection with the Credit Agreement, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in, to and under the Intellectual Property Collateral to the Grantors.

The Agent agrees, at Grantors' expense, to cooperate with Grantors and to provide Grantors with the information and additional authorization reasonably required or desirable to effect the release of the Agent's security interest in the released collateral described herein.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
