**RELEASE OF SECURITY INTEREST
IN CERTAIN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK COLLATERAL, dated as of June 5, 2017 (this “Release”), is made by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH**, as collateral agent for the Lenders and the other Secured Parties (the “Agent”), in favor of **DELL SOFTWARE INC.** (“Grantor”), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Trademark Security Agreement (as defined below).

WITNESSETH

WHEREAS, pursuant to the Second Lien Trademark Security Agreement, dated as of October 31, 2016 (the “Trademark Security Agreement”), and recorded with the U.S. Patent and Trademark Office on November 10, 2016, at Reel/Frame No. 5917/0759, Grantor granted to the Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademarks set forth on Schedule A attached hereto (the “Released Registered Trademarks”); and

WHEREAS, Grantor has requested that the Agent release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Trademarks; and

WHEREAS, the Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Trademarks, and reassign any all rights, title and interest in the same to Grantor.

NOW, THEREFORE, the Agent, without recourse, representation or warranty of any kind or nature, and at Grantor’s sole cost and expense, hereby terminates, cancels and releases its security interest in and continuing lien on all right, title and interest of Grantor in, to and under the Released Registered Trademarks, and any and right, title and interest of the Agent in such Released Registered Trademarks, including all goodwill associated therewith, is hereby assigned, transferred, and conveyed to Grantor.

The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.
