RELEASE OF SECURITY INTEREST
IN TRADEMARKS

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Collateral Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Trademarks, and retransfers to Grantor, according to their interests therein, without representation or warranty of any kind, express or implied, free and clear of any claims by Collateral Agent, all of Collateral Agent's right, title and interest in and to the Released Trademarks, the goodwill associated therewith, and all causes of action for past infringement, if any.
