**NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)**

This Notice of Trademark Security Agreement, dated as of June 2, 2017, is made with regard to NPB COMPANY, INC., a Kansas corporation ("Borrower"), having an address for notice at 900 S. IN WITNESS WHEREOF, the undersigned has executed this Notice of Trademark Security Agreement as of the date written above.

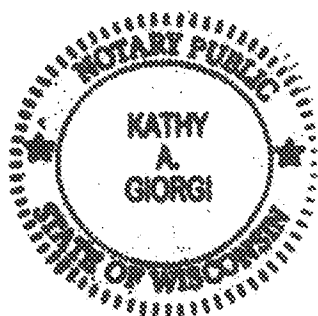
