## ASSIGNMENT

WHEREAS, LIBRAGEN, a limited company, organized and existing under the laws of France, having a place of business at Canal Biotech, 3 rue des Satellites, 31400 Toulouse, France (hereinafter "ASSIGNOR"), has adopted and used the trademark **INOVEOL**, and has filed an application to register the Trademark in the United States Patent and Trademark Office under U.S. Trademark Application Serial No. 87/185,027, for use in connection with "Chemical products for use in the manufacture of cosmetics, namely, raw materials as additive or active ingredients for cosmetic purposes, for anti-aging, moisturizing, skin complexion, lightening, protection, soothing, functional agent, firming and plumping purposes, anti hair loss, hair growth stimulation" (the Trademark and the corresponding U.S. Application are collectively referred to hereinafter as the "Trademark"); and

WHEREAS, Givaudan S.A., a corporation organized and existing under the laws of Switzerland, having a place of business at 5, Chemin de la Parfumerie, CH - 1214 Vernier, Switzerland (hereinafter "ASSIGNEE"), is desirous of acquiring the aforesaid Trademark, together with whatever rights ASSIGNOR may have in and to the Trademark in the United States, and the goodwill associated with the Trademark in the United States.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR does hereby assign and transfer to ASSIGNEE the entire right, title, and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, and the pending Application therefor, and the registration and renewal thereof, the business to which the Trademark pertains, and any and all other




rights which ASSIGNOR has enjoyed thereunder in the United States, including any and all rights of recovery based on past infringement of the Trademark and/or registration, the same to be held and enjoyed by ASSIGNEE, its successors and assigns, to the full end of the term for which the Trademark is registered, and any renewal of the term thereof.

This Assignment shall be binding upon the successors, assigns, and other legal representatives of Libragen as ASSIGNOR, and shall inure to the benefit of the successors, assigns, and other legal representatives of Givaudan S.A., as ASSIGNEE.
