TRADEMARK ASSIGNMENT AGREEMENT

WHEREAS, the Assignor wants to assign the Trademark to Assignee for the United States of America ("Territory") and that the Trademarks shall be assigned and transferred to the Assignee.

Further, the parties agree that from the Effective Date the rights of the Assignor are to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, at common law and/or to the end of the term or terms for which registration of the Assignor's Trademark may be granted or renewed, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all claims for damages by reason of past infringement of the Assignor's Trademark with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns or other legal representatives.
2. The parties acknowledge that Assignor shall retain all rights and be free to use the Trademarks outside of the Territory


