**GRANT OF SECURITY INTEREST IN TRADEMARKS AND  
U.S. TRADEMARK REGISTRATIONS**

WHEREAS, pursuant to the Assignment and Assumption Agreement, dated as of November 9, 2016, ("the Agreement"), by and among Grantor and Edward M. Notarius and Patricia A. Schweizer as Trustees of the Notarius Schweizer Family Trust Dated June 9, 2016 ("Secured Party"), Grantor granted, assigned and conveyed to Secured Party a continuing security interest in, and lien on, said U.S. marks, together with the goodwill of the business symbolized by or connected with the use of said marks in the U.S., and the U.S. registrations and renewals thereof; the proceeds thereof, including but not limited to license royalties and proceeds of infringement suits; and the right to sue for past, present and future infringements (collectively the "Trademark Collateral"); and

WHEREAS, pursuant to the Agreement, Grantor agreed to execute and deliver to Secured Party this Grant of Security Interest in Trademarks and U.S. Trademark Registrations ("Grant") for purposes of filing the same with the PTO to confirm, evidence and perfect the security interest in the Trademark Collateral granted pursuant to the Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and subject to all applicable terms and conditions of the Agreement, which are incorporated by reference as if fully set forth herein, Grantor hereby grants, assigns and conveys to Secured Party a continuing first priority security interest in, and lien on, the Trademark Collateral


The parties intend that this Grant is for recordation purposes only and its terms shall not modify the applicable terms and conditions of the Agreement, which govern the Secured Party's interest in the Trademark Collateral.

Grantor hereby acknowledges the sufficiency and completeness of this Grant to create the security interest in the Trademark Collateral for the Secured Party, and Grantor hereby requests the PTO to file and record the same.


Grantor and Secured Party hereby acknowledge and agree that the security interest in the Trademark Collateral may be terminated only in accordance with the terms of the Agreement.


