RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

WHEREAS, STACK SPORTS PERFORMANCE TRAINING, LLC, a Delaware limited liability company ("Grantor"), granted and pledged a continuing security interest to SILICON VALLEY BANK, a California corporation ("Bank"), in all of Grantor's right, title, and interest in, to, and under Grantor's intellectual property, including the trademarks set forth on Exhibit A (all of Grantor's intellectual property, including the trademarks set forth on Exhibit A, collectively, the "Grantor IP"), in each case as further set forth in the Intellectual Property Security Agreement, dated May 28, 2014, between Grantor and the Bank (the "Security Agreement");

WHEREAS, an executed copy of the Security Agreement was recorded in the United States Patent and Trademark Office against the trademarks set forth on Exhibit A on March 22, 2016 at Reel 5755, Frame 0099; and

WHEREAS, Grantor has requested that the Bank release and reassign its interest in the Grantor IP;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Bank hereby:

1. releases and reassigns to Grantor any and all mortgages, security interests, liens, right, title and interest of the Bank pursuant to the Security Agreement in the Grantor IP, including all of the goodwill associated thereto, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to the Bank pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
