RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of June 7, 2017 (the "Effective Date"), is made by GE Capital US Holdings, Inc. (as assignee of General Electric Capital Corporation), with a place of business located at 901 Main Avenue, Norwalk, CT 06851-1168 (the "Secured Party"), in favor of The McCall Pattern Company, a Delaware corporation with its headquarters located at 120 Broadway, 34th Floor, New York, NY 10271 (the "Grantor").

WHEREAS, pursuant to that certain security agreement, dated on or about March 14, 2001, by and between the Secured Party (as Agent), the Grantor and certain other parties thereto (as amended, amended and restated, or otherwise modified from time to time, the "Security Agreement"), the Grantor granted to the Secured Party a security interest in and to certain collateral;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on March 27, 2001 at Reel/Frame 2269/0090.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby agrees as follows:

1. Release. The Secured Party (as Agent), without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the trademarks of the Grantor and all proceeds of any of the foregoing (the "Trademark Collateral"), including the trademark registrations and applications set forth in Schedule A attached hereto, arising under the Security Agreement. If and to the extent that the Secured Party has acquired any right, title or interest in and to the Trademark Collateral under the Security Agreement, the Secured Party, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.

2. Termination. The Secured Party, without representation or warranty of any kind, terminates and cancels the Security Agreement and any trademark security agreement that the Grantor may have executed and delivered for recording with the United States Patents and Trademark Office.

3. Further Assurances. The Secured Party agrees to take all further actions, and to provide to the Grantor and its successors, assigns or other legal representatives all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

4. Governing Law. This Release shall be governed exclusively under the laws of New York.


