FLSA Holdings, Inc., a corporation organized and existing under the laws of the State of Delaware ("Parent")

DOES HEREBY CERTIFY THAT:

FIRST: Parent is a corporation organized pursuant to the provisions of the General Corporation Law of the State of Delaware on September 28, 2005.

SECOND: Parent owns all of the issued and outstanding shares of capital stock of Fire & Life Safety America, Inc. ("Subsidiary"), a corporation organized and existing under the laws of the Commonwealth of Virginia.

THIRD: The laws of the Commonwealth of Virginia, under which the Subsidiary is organized permit the proposed merger and Subsidiary has complied with all of the applicable provisions of the Virginia Stock Corporation Act.

FOURTH: The board of directors of Parent by unanimous written consent determined to merge Parent with and into Subsidiary. The Merger was approved by the holders of at least a majority of the outstanding shares of stock of Parent. Attached hereto as Exhibit A is a copy of the relevant recitals and resolutions adopted as of February 22, 2017 by joint unanimous written consent of the board of directors and sole stockholder of each of Parent and Subsidiary, approving the merger of Parent with and into Subsidiary under Section 253 of the General Corporation Law of the State of Delaware and the applicable provisions of the Virginia Stock Corporation Act.

FIFTH: Parent hereby merges with and into Subsidiary (the "Merger"), pursuant to this Certificate of Ownership and Merger (this "Merger Certificate"). The Merger shall be effective as of 11:59 p.m. Eastern Time on February 23, 2017 (the "Effective Time"). Subsidiary shall be the surviving corporation, and the separate existence of Parent shall cease as of the Effective Time.

Consent to Service of Process. Subsidiary hereby agrees that it may be served with process in the State of Delaware in any proceeding for enforcement of any obligation of Parent, as well as

for enforcement of any obligation of Subsidiary arising from the Merger. Subsidiary hereby irrevocably appoints the Secretary of State of the State of Delaware and the successors of such officer its attorney in the State of Delaware upon whom may be served any notice, process or pleading in any action or proceeding against it to enforce against Subsidiary any obligation of Parent. In the event of such service upon the Secretary of State of the State of Delaware or the successors of such officer, such service shall be mailed to the principal office of Subsidiary at 3017 Vernon Road, Suite 100, Richmond, VA 23228.
