Assignor represents and warrants that it is the owner of the entire right, title, and interest in and to the Marks; that it has the right and power to assign ownership of the Marks; that there are no other agreements with any other party in conflict with such assignment; and that it knows of no third parties with prior rights that may threaten or otherwise validly challenge the rights assigned herein to the Marks.
