ARTICLE 1
STATEMENT OF CONVERSION

In accordance with the requirements of RCW 23B.09.005, Transfair North America International Freight Services, Inc., a Washington corporation (the "Company"), hereby reports to the Secretary of State of the State of Washington that it has converted into a limited liability company organized in the state of Washington (the "Conversion").

ARTICLE 2

APPROVAL


The Conversion was approved by the sole shareholder of the Company in accordance with RCW 23B.09.030.
