TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Security Interest in Trademarks (this "Release") is made as of June 14, 2017, and granted by CERBERUS BUSINESS FINANCE, LLC, in its capacity as collateral agent pursuant to the Financing Agreement (as defined below) (in such capacity, the "Agent").

WHEREAS, pursuant to the Financing Agreement, dated as of January 11, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Financing Agreement"), by and among Accuray Incorporated, a Delaware corporation (the "Parent"), certain subsidiaries of the Parent, the lenders from time to time party thereto and the Agent, and the Pledge and Security Agreement, dated as of January 11, 2016 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), ACCURAY INCORPORATED (the "Grantor") granted to the Agent a security interest (the "Security Interest") in certain Collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to the terms and conditions of that certain Assignment for Security - Trademarks, dated as of January 11, 2016 (the "Trademark Security Agreement"), between the Grantor and the Agent, the Grantor pledged to the Agent, for the benefit of the Secured Parties, a Security Interest in and continuing lien on all of such Grantor's right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on January 13, 2016 at Reel 5708, Frame 0908;

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in and lien on the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. **Definitions.** Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement. The term "Trademark Collateral," as used herein, shall mean the U.S. Trademark set forth on Schedule I hereto.
2. **Release of Security Interest.** The Agent hereby terminates the Trademark Security Agreement and hereby terminates, cancels, discharges and releases its security interest in and any lien upon the Trademark Collateral, in each case without representation, warranty or recourse. If and to the extent the Agent has acquired any right, title or interest in, to or under any of the Trademark Collateral, then the Agent hereby assigns, transfers, conveys and delivers such right, title or interest to the Grantor.
3. **Further Assurances.** The Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor to more fully and effectively effectuate the purposes of this Termination and Release, in each case at the Grantor's sole expense.
4. **Governing Law.** This Termination and Release shall be construed in accordance with and governed by the law of the State of New York.

IN WITNESS WHEREOF, the Agent has caused this Termination and Release to be executed and delivered by its duly authorized officer as of the date first set forth above.
