TRADEMARK ASSIGNMENT (NUNC PRO TUNC)

THIS TRADEMARK ASSIGNMENT (NUNC PRO TUNC) (this "Assignment") is entered into effective as of January 18, 2011 ("Effective Date") by and between ARNCO CORPORATION, a Ohio corporation, with its principal office at 860 Garden Street, Elyria, Ohio 44035 ("Assignor"), and DURA-LINE CORPORATION, a Delaware corporation, with its principal office at 11400 Parkside Drive, Suite 300, Knoxville, Tennessee 37934 ("Assignee").

WHEREAS, that certain Trademark Assignment Agreement dated May 9, 2011 was entered into between parties named therein as "ARNCO CORPORATION, a Delaware corporation" and Assignee, and the reference to ARNCO CORPORATION, a Delaware corporation" (the "May 9, 2011 Trademark Assignment") was inadvertent and incorrect (and refers to a non-existent entity), and should have correctly referred to "ARNCO CORPORATION, an Ohio corporation", which is the Assignor in this Assignment;

WHEREAS, Assignor and Assignee desire to enter into this further corrective Assignment, with a *nunc pro tunc* retroactive effective date of January 18, 2011 to properly document the intended transaction and to supercede May 9, 2011 Trademark Assignment, including without limitation for the purposes of recording this Assignment with the US Patent and Trademark Office;

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, the United States trademark registrations and foreign trademark registrations set forth on Schedule A attached hereto, in each case, together with the goodwill of the business associated therewith (collectively, the "Marks"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Marks, for the United States and for all foreign countries, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country including without limitation all goodwill and all common law rights associated with or related to the Marks, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries, to record Assignee as the assignee and owner of the Marks.

IN TESTIMONY WHEREOF, the Assignor and Assignee have caused this Assignment to be signed and executed by the undersigned officers thereunto duly authorized effective the 18th day of January, 2011.
