ASSIGNMENT OF TRADEMARKS

BETWEEN:

THERMOCERAMIX, INC., a corporation incorporated under the laws of the State of Delaware (“**Thermoceramix**”)

(the “**Assignor**”)

- and -

REGAL WARE, INC., a corporation incorporated under the laws of the State of Delaware

(the “**Assignee**”)

CONTEXT:

- A. The Assignor is the owner of the trademarks that are set out in Exhibit A to this Assignment (the “**Trademarks**”).
- B. The Assignor desires to transfer the entire ownership of the Trademarks to the Assignee.

THEREFORE, the parties agree as follows:

1. Assignment

The Assignor hereby sells, assigns and transfers to the Assignee, its successors and assigns, its entire right, title and interest in and to the Trademarks, including:

- 1.1 all continuations, continuations-in-part, divisions, renewals, extensions and reissues of any of the Trademarks;
- 1.2 the right to claim all benefits and priority rights with respect to the Trademarks under any applicable convention;
- 1.3 all privileges in and to the Trademarks, including but not limited to, the benefit of any attorney client privilege or attorney work product privilege, for all countries; and
- 1.4 the right to sue for all past, present and future infringements of, and to collect all income, royalties, damages and payments now or hereafter due or payable with respect to any of the Trademarks.

The Assignor authorizes and requests the United States Patent and Trademark Office to record this Assignment to the Assignee as assignee of the Assignor’s entire interest, and the Assignor covenants that it has full right to convey the entire interest assigned in this Assignment, and that it has not executed, and will not execute, any agreements in contravention of this Assignment.

2. Further Assurances

The Assignor agrees to execute, upon request, any further papers that may be necessary or desirable to enable the Assignee or its successors and assignees (as applicable), to file and prosecute any trademark application forming part of the Trademarks, and to vest in the Assignee the exclusive title to the Trademarks.

3. Enurement

This assignment will enure for the benefit of the Assignee and its successors and assignees and will be binding upon the Assignor and its heirs, executors, administrators, successors, assigns and legal representatives.

4. Appointment as Attorney

The Assignor irrevocably appoints the Assignee as the Assignor's attorney-in-fact, with full authority in the place of the Assignor and in the name of the Assignor to take any action and to execute any instrument which the Assignee may deem necessary or advisable to accomplish the purposes of this Assignment, and to make any filings as appropriate, to effect the full and complete assignment as contemplated under this Assignment.


5. Correction of Errors




