**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks (this "Release") is executed as of June 13, 2017 by Roynat Asset Finance ( "Lender") pursuant to that certain Loan Agreement, dated as of January 31, 2014, by and between Bijoux Nouveau, Inc. ("Borrower") and Roynat Asset Finance, a division of Roynat, Inc. (as amended, supplemented or otherwise modified from time to time, the "Loan Agreement"); capitalized terms used herein but not defined shall have the meanings set forth in the Loan Agreement).

WHEREAS, in connection with the Loan Agreement, Lender and Borrower have entered into that certain Trademark Security Agreement dated as of January 31, 2014 (the "Trademark Security Agreement"), and recorded it with the United States Patent and Trademark Office on February 6, 2014 as Reel/Frame 5211/0004.

WHEREAS, pursuant to the Trademark Security Agreement, the Borrower granted to Lender a lien upon the Trademark Collateral (as defined in the Trademark Security Agreement) in order to secure the prompt and complete payment and performance of all Obligations arising under the Loan Agreement, including a security interest in the Trademark Collateral identified on Schedule A attached hereto.

WHEREAS, in connection with payoff by Borrower under the Loan Agreement, the Trademark Security Agreement has been terminated.

WHEREAS, Lender has agreed to terminate all of its security interest in the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

Lender hereby unconditionally releases, discharges, relinquishes and terminates any and all liens and security interests in the Trademark Collateral and hereby terminates the Trademark Security Agreement, and authorizes the recordation of this Release with the United States Patent and Trademark Office.

To the extent that the Lender shall be deemed to have any right, title or interest in the Trademark Collateral, Lender hereby retransfers and reassigns without recourse, representation or warranty, all of such right, title and interest in the Trademark Collateral as set forth hereto on Schedule A, to the Borrower.


