Section 1.1 Trademark Assignment Assignor hereby assigns to Assignee all right, title and interest in and to the Trademarks and the registrations therefor listed in Schedule A and throughout the world together with all common law rights related thereto, with the goodwill of the business symbolized by the Trademarks, along with the right to sue and recover for, and the right to profits, penalties or damages due or accrued arising out of or in connection with any and all past, present and future infringements or dilution of or damage or injury to the Trademarks or such represented goodwill.

Section 1.2 Acknowledgement. Assignor hereby acknowledges and agrees that from and after the execution date hereof, as between the Parties, Assignee shall be the exclusive owner of the Intellectual Property Rights.

Section 1.3 Cooperation. This Assignment has been executed and delivered by the Assignor to be used for recording the Assignment herein with the appropriate government entity. At Assignee's sole cost and expense, Assignor shall execute and deliver such other documents and take all other actions which Assignee, its successors and/or assigns may reasonably request to effect the terms of this Assignment and to perfect Assignee's right, title and interest in and to the Intellectual Property Rights, including, without limitation, its recordation in relevant state and national patent offices.


