All rights in the Assigned Trademarks are to be held and enjoyed by Assignee, for its own use and enjoyment and for the use and enjoyment of its successors and assigns to the end of the term of any resulting trademark rights, as fully and entirely as the same would have been held and enjoyed by Assignor if the assignment described in this Assignment had not been made.





