**TRADEMARK ASSIGNMENT**

WHEREAS, ChuanQi IP Co., Ltd., a corporation organized under the laws of South Korea, at 5F Wemade Tower, 49 Daewangpangyo-ro, 644 beon-gil, Bundang-gu, Seongnam-si, Gyeonggi-do, Republic of Korea ("ChuanQi"), wishes to acquire the Trademark Rights.

NOW, THEREFORE, in view of the legally sufficient and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, WeMade on May 19, 2017 assigned and transferred to ChuanQi all right, title and interest in and to the Trademark Rights including, without limitation, the GOODWILL of the business in which the marks are used.

WeMade shall, without further consideration, execute any additional documents and take such further action as may be requested to vest in ChuanQi good, valid and marketable title to the Trademark Rights.
