**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of June 16, 2017 and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Lender under the below-defined Security Agreement, having an office at 2 North Lake Avenue, Suite 440, Pasadena, CA 91101 ("Grantee") to **GLOBAL WEST COMMUNICATIONS, INC.** (now known as eMOBUS, LLC), a California corporation d/b/a eMOBUS ("Grantor"), with its chief executive office at 6215 Ferris Square, Suite 250, San Diego, CA 92121.

WHEREAS, pursuant to that certain Security Agreement (Trademarks) dated as of October 14, 2015, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on January 19, 2016, at Reel 5711 and Frame 0677; and

WHEREAS, Grantee now desires to terminate the Security Agreement and release the security interest granted and recorded against each Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall have the meaning set forth in the Security Agreement and shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademarks and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademarks, along with any goodwill in the Trademarks that Grantee may have acquired.
