TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of March 2, 2017 by **PATRIOT BANK, N.A.** (the "*Lender*"), in favor of **TRANS-HIGH CORPORATION**, a New York corporation (the "*Grantor*").

WHEREAS, the Grantor executed and delivered that certain Intellectual Property Security Agreement, dated as of May 23, 2016 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Agreement*"), granting the Lender a security interest in and lien on certain Trademarks described and defined therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on May 25, 2016, at Reel 5800, Frame 0029;

WHEREAS, the Grantor has requested that the Lender hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademarks described in the Agreement (collectively, the "*IP*") as herein provided; and

WHEREAS, the Grantor has requested that the Lender provide a document suitable for recording in the USPTO to evidence the release of its security interests in and liens on the IP as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby:

1. terminates the Agreement and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under the IP, and all goodwill associated therewith, including the IP identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO by the Grantor.
