Assignment of Trademark and Service Mark

Be it known that in consideration of the payment by Assignee to Assignor of the sum of one dollar (\$1.00), and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns, and transfers unto Assignee the full, exclusive, and entire right, title, and interest in and to the Marks, and the business goodwill associated therewith, including, without limitation, all renewals therefor, all proceeds therefor (including, but not limited to, all license royalties and proceeds of infringement suits), the right to sue for past, present, and future infringements, and the goodwill of the business(es) associated with and symbolized by the Trademarks.

The trademarks are being assigned in conjunction with the goodwill associated therewith, as well as with the right to sue for past, present, and future infringements. An assignment of trademarks without the assignment of the associated goodwill would be invalid.
