**AMENDMENT AND REAFFIRMATION OF  
PATENT AND TRADEMARK SECURITY AGREEMENT**

THIS AMENDMENT AND REAFFIRMATION OF PATENT AND TRADEMARK SECURITY AGREEMENT (this "Agreement") is made and entered into as of June 14, 2017, by RANDA ACCESSORIES LEATHER GOODS LLC, a Delaware limited liability company (the "Company"), SWANK HOLDINGS, INC., a Delaware corporation formerly known as Swank, Inc. ("Swank", and together with the Company, the "Grantors", and each individually, a "Grantor") and JPMORGAN CHASE BANK, N.A., in its capacity as Administrative Agent under the Patent and Trademark Security Agreement (as defined below) (in such capacity, together with any successors and assigns, the "Administrative Agent") for the benefit of itself, the Lenders and the other Secured Parties under that certain Credit Agreement (as defined below).

RECITALS:

WHEREAS, the Grantors, certain Affiliates of the Grantors, the Administrative Agent, and the financial institutions from time to time party thereto are parties to that certain Credit Agreement dated as of May 17, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement").

WHEREAS, the Grantors, certain Affiliates of the Grantors and the Administrative Agent entered into that certain Pledge and Security Agreement dated as of May 17, 2012 (as further amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") in connection with the Credit Agreement.

WHEREAS, the Grantors entered into that certain Patent and Trademark Security Agreement dated as of May 17, 2012 (as amended, restated, supplemented or otherwise modified from time to time, the "Patent and Trademark Security Agreement") in connection with the Security Agreement.

WHEREAS, pursuant to the Credit Agreement, the Patent and Trademark Security Agreement and the Security Agreement, as collateral security for all of the Secured Obligations, each Grantor has pledged and assigned to the Administrative Agent, and granted to the Administrative Agent, for the benefit of itself, the Lenders and the other Secured Parties a continuing security interest in all of its Trademarks and Patents, including, without limitation, the applications and registrations thereof and all proceeds thereof (collectively, the "Collateral").

WHEREAS, each Grantor desires to amend certain provisions of the Patent and Trademark Security Agreement and reaffirm its obligations under the Patent and Trademark Security Agreement on the terms and conditions herewith in connection with the Credit Agreement, the Patent and Trademark Security Agreement and the Security Agreement. Unless otherwise noted, capitalized terms used but not defined herein have the meanings assigned to them in the Security Agreement or the Credit Agreement, as the case may be.

Accordingly, in consideration of the mutual agreements herein contained and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

SECTION 1. Recitals. Each and all of the foregoing recitals are true and correct and are incorporated herein by reference.

SECTION 2. Amendments to the Patent and Trademark Security Agreement.

(a) Specified Trademarks. By executing and delivering this Agreement, each Grantor hereby grants to the Administrative Agent, a security interest in and continuing lien on all of such Grantor's right, title and interest in, to and under the Trademarks described on Schedule 1 attached hereto (the "Specified Trademarks"), subject to the terms and conditions of the Security Agreement and the Patent and Trademark Security Agreement. Schedule 1 of the Patent and Trademark Security Agreement is hereby replaced in its entirety with Schedule 1 attached hereto and Schedule 1 attached hereto shall be deemed to be the attached Schedule 1 to the Patent and Trademark Security Agreement as of the date hereof.

(b) Specified Patents. By executing and delivering this Agreement, each Grantor hereby grants to the Administrative Agent, a security interest in and continuing lien on all of such Grantor's right, title and interest in, to and under the Patents described on Schedule 2 attached hereto (the "Specified Patents"), subject to the terms and conditions of the Security Agreement and the Patent and Trademark Security Agreement. Schedule 2 of the Patent and Trademark Security Agreement is hereby replaced in its entirety with Schedule 2 attached hereto and Schedule 2 attached hereto shall be deemed to be the attached Schedule 2 to the Patent and Trademark Security Agreement as of the date hereof.

SECTION 3. Reaffirmations. The terms and provisions set forth in this Agreement shall modify and supersede all inconsistent terms and provisions set forth in the Patent and Trademark Security Agreement, and the terms and provisions (unless amended pursuant to this Agreement) of the Patent and Trademark Security Agreement are reaffirmed and confirmed and shall continue in full force and effect. Each Grantor hereby reaffirms and confirms its obligations to the Administrative Agent, for the benefit of itself, the Lenders and the other Secured Parties under the Patent and Trademark Security Agreement and acknowledges that the security interest in the Collateral granted thereunder shall secure all of the Secured Obligations, as amended, increased and/or extended pursuant to the Credit Agreement. As reaffirmed hereby, the Patent and Trademark Security Agreement shall continue to be legal, valid, binding and enforceable in accordance with their respective terms.

SECTION 4. No Waiver. Nothing contained in this Agreement shall be construed as a waiver by the Administrative Agent of any covenant or provision of the Patent and Trademark Security Agreement, the other Loan Documents, or of any other contract or instrument between the Grantors and the Administrative Agent, and the failure of the Administrative Agent at any time or times hereafter to require strict performance by the Grantors of any provision thereof shall not waive, affect or diminish any right of the Administrative Agent to thereafter demand strict compliance therewith. The Administrative Agent hereby reserves all rights granted under the Patent and Trademark Security Agreement, the other Loan Documents, this Agreement and

any other contract or instrument between and/ or among the Grantors and the Administrative Agent.

SECTION 5. Severability. Any provision of this Agreement which is prohibited or unenforceable in any jurisdiction shall, as to such jurisdiction, be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining portions hereof or affecting the validity or enforceability of such provision in any other jurisdiction.

SECTION 6. APPLICABLE LAW. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.

SECTION 7. Successors and Assigns. This Agreement is binding upon and shall inure to the benefit of the Grantors and the Administrative Agent and their respective successors and assigns, except the Grantors may not assign or transfer any of its rights or obligations hereunder without the prior written consent of the Administrative Agent, other than as expressly permitted under the terms of the Loan Documents.

SECTION 8. Counterparts. This Agreement may be executed in any number of counterparts and by different parties hereto in separate counterparts, each of which when so executed and delivered shall be deemed an original but all of which when taken together shall constitute but one and the same instrument. Delivery of an executed signature page of this Agreement by fax or other electronic transmission shall be effective as delivery of a manually executed counterpart hereof.

SECTION 9. Effect of Waiver. No consent or waiver, express or implied, by the Administrative Agent to or for any breach of or deviation from any covenant, condition or duty by any Grantor shall be deemed a consent or waiver to or of any other breach of the same or any other covenant, condition or duty.

SECTION 10. Headings. The headings of this Agreement are for purposes of reference only and shall not limit or otherwise affect the meaning hereof.


