RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of August 12, 2014, by **CAPITALSOUTH PARTNERS FUND II LIMITED PARTNERSHIP**, a North Carolina limited partnership (“CapitalSouth II”), **CAPITALSOUTH PARTNERS SBIC FUND III, L.P.**, a Delaware limited partnership (“CapitalSouth III”), **CENTERFIELD CAPITAL PARTNERS II, L.P.**, a Delaware limited partnership (“CCP II”), **CCP II-A, L.P.**, a Delaware limited partnership (“CCP II-A”), **CCP II-A BLOCKER CORPORATION**, a Delaware corporation (“CCP II Blocker”), **CENTERFIELD CAPITAL PARTNERS III, L.P.**, a Delaware limited partnership (“CCP III”), **CCP III-A, L.P.**, a Delaware limited partnership (“CCP III-A”), **CCP III-A BLOCKER CORPORATION**, a Delaware corporation (“CCP III Blocker”), and **CCP III-SBIC, L.P.**, a Delaware limited partnership (“CCP SBIC” and, together with CapitalSouth II, CapitalSouth III, CCP II, CCP II-A, CCP II Blocker, CCP III, CCP III-A, CCP III Blocker and CCP SBIC, the “Purchasers” and each a “Purchaser”) in favor of **MJC ACQUISITION, LLC**, an Indiana limited liability company (the “Grantor”).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated July 16, 2012, made by the Grantor in favor of the Purchasers (the “Security Agreement”) recorded on July 30, 2012 on Reel No. 4831, Frame 0380, United States Patent and Trademark Office, the Grantor granted a security interest in certain trademarks in favor of the Purchasers to secure certain debt owing from the Grantor to the Purchasers;

WHEREAS, the Grantor has requested that the Purchasers (i) terminate and release the liens and interests of the Purchasers in the Grantor’s trademarks as set forth in **Exhibit A** attached hereto (collectively, the “Trademarks”), and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and

WHEREAS, the Purchasers have agreed to such release and termination.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Purchaser hereby releases and terminates its security interests in the Trademarks, and reassigns to the Grantor all right, title and interest of such Purchaser in and to the Trademarks.


