(c) any and all pending federal and state applications to register the Marks;

(d) all common law rights in, to and under the Marks;

(e) all other rights in, to and under the Marks, together with and including all goodwill of the business symbolized by the Marks;

(f) any and all rights to royalties, profits, compensations, license fees or other payments or remuneration of any kind relating to the Marks, and/or the goodwill under the Marks; and

(g) all claims or causes of action the Assignors have or may have in connection with the Marks including, but not limited to, the right to sue and recover damages for any and all past infringements of the Marks.

The Assignors hereby covenant that they have full right to convey the entire interest herein assigned, and that they have not executed, and will not execute, any agreements inconsistent herewith.

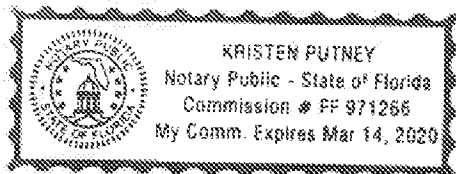
