**RELEASE OF
SECURITY INTEREST IN TRADEMARK RIGHTS**

RELEASE dated as of May 30, 2017 (this "Release"), from JPMORGAN CHASE BANK, N.A., as Administrative Agent (the "Administrative Agent"), for the several banks and other financial institutions (the "Lenders"), parties to the Credit Agreement, dated as of September 30, 2014, as amended on December 23, 2016 (as may be modified and supplemented and in effect from time to time, the "Credit Agreement"), among Borrower, each of the other grantors party thereto, the Lenders, and the Administrative Agent, in favor of HARRY LONDON CANDIES, INC., an Ohio corporation, located at 5353 Lauby Road, North Canton, OH 44720 (the "Grantor").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, dated as of September 30, 2014, in favor of the Administrative Agent, as reaffirmed on December 23, 2016 (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), Grantor granted a security interest to the Administrative Agent in certain collateral, including Trademark Collateral (as that term is defined in the Security Agreement);

WHEREAS, pursuant to that certain Grant of Security Interest in Trademark Rights dated as of September 30, 2014, among the Administrative Agent and Grantor (the "Trademark Security Agreement"), Grantor, by reference to the Security Agreement, reaffirmed its intent to grant the security interest to the Administrative Agent specifically in that certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded by the United States Trademark Office on November 3, 2014 at Reel 5392, Frame 0985; and

WHEREAS, the Administrative Agent now desires to release the entirety of its security interest in those Trademarks set forth on Schedule A hereto (together with all of the goodwill associated therewith, the "Released Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Security Agreement.
2. Release of Security Interest. The Administrative Agent, for the benefit of the Secured Parties, hereby releases, terminates, cancels and discharges all of its security interest in the Released Collateral, and hereby re-assigns, conveys and transfers to the Grantor any right, title and interest that the Administrative Agent may have in the Released Collateral.


3. Reservation of Rights. For clarity, the Administrative Agent's security interest in and to all Collateral other than the Released Collateral shall remain in full force and effect.

4. Governing Law. This Release is governed by the laws of the State of New York.

5. Further Assurances. The Administrative Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
