## TERMINATION OF TRADEMARK SECURITY INTEREST

This **TERMINATION OF TRADEMARK SECURITY INTEREST**, dated as of June 9, 2017, is made by SunTrust Bank, a National Banking Association, as administrative agent (the "Administrative Agent").

WHEREAS, Hirschfeld Steel Group LP, a Texas limited partnership (the "Grantor"), executed a security interest agreement dated June 30, 2015 ("Trademark Security Agreement") granting to the Administrative Agent a security interest in certain personal property, including without limitation, the trademarks listed on Exhibit A hereto ("Trademarks");
