TRADEMARKS RELEASE OF SECURITY INTEREST

THIS RELEASE dated as of June 21, 2017, by MORGAN STANLEY SENIOR FUNDING, INC., as Agent (as defined below) for the Lenders. Terms used herein and not otherwise defined shall have the meanings assigned to such terms in the Credit Agreement (as defined below).

A. Reference is made to the First Lien Credit and Guaranty Agreement dated as of August 19, 2016 (as amended by the First Amendment, dated as of November 7, 2016 and as may be further amended, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), by and among SAFWAY GROUP HOLDING LLC, a Delaware limited liability company (the "*Borrower*"), BADGER INTERMEDIATE HOLDINGS LLC ("*Holdings*"), a Delaware limited liability company, the LENDERS party thereto and MORGAN STANLEY SENIOR FUNDING, INC., as agent (in such capacity, the "*Agent*") for the Lenders.

B. Reference is made to (i) the First Lien Pledge and Security Agreement, dated as of August 19, 2016 (the "*Pledge and Security Agreement*") by and among Borrower, Holdings, each of the grantors from time to time party thereto and the Agent, (ii) the First Lien Trademark Security Agreement, dated as of August 19, 2016 (the "*Safway Security Agreement*") made by Safway Services, LLC, a Delaware limited liability company, Safway Group Holding LLC, a Delaware limited liability company, North American Coatings, LLC, a Delaware limited liability company, All-American Scaffold, LLC, an Iowa limited liability company and Redi Solutions, LLC, a Utah limited liability company (the "*Original Grantors*"), in favor of the Agent and (iii) the First Lien Trademark Security Agreement, dated as of January 13, 2017 (the "*SafeWorks Security Agreement*") and, collectively with the Credit Agreement, the Pledge and Security Agreement and the Safway Security Agreement, the "*Security Documents*"), made by SafeWorks, LLC, a Delaware limited liability company ("*SafeWorks*" and, together with the Original Grantors, the "*Grantors*"), in favor of the Agent, pursuant to which the Grantors, among other things, granted a security interest to the Agent, for the benefit of certain secured parties named therein, in personal property of the Grantors, including all right, title and interest of the Grantors in, to and under the Trademark Collateral (as defined in the Safway Security Agreement and SafeWorks Security Agreement, as applicable), including, without limitation, those registered trademarks and pending trademark applications set forth on Schedule A hereto, which security interest in the case of the Original Grantors was recorded with the United States Patent & Trademark Office on August 19, 2016 on Reel 5859 Frame 0761 and which security interest in the case of SafeWorks was recorded with the United States Patent & Trademark Office on January 20, 2017 on Reel 005971 Frame 0483.


C. In connection with the termination of the Credit Agreement, the

Borrower has informed the Agent of its desire to obtain the release of all right, title and interest of the Agent, the Lenders and each other grantee or beneficiary in and to the Trademark Collateral granted under the Security Documents.

Accordingly, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, releases and discharges all of its right, title and interest (including, without limitation, security interests) in and to the Trademark Collateral (including, without limitation, the registered trademarks and pending trademark applications set forth on Schedule A attached hereto) pursuant to the Security Documents, the debt secured thereby having been paid and satisfied in full. Any right, title or interest of the Agent in the Trademark Collateral under the Security Documents shall hereby cease and become void.




