**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination"), is dated as of June 19, 2017, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Agent under the below-defined Security Agreement, having an office at 100 Pine Street, Suite 1500, San Francisco, CA 94111 ("Grantee") to **EHEALTH SOLUTIONS INC.**, a Delaware corporation d/b/a SigmaCare ("SigmaCare") and **EMR ACQUISITION LLC**, a Delaware limited liability company ("EMR"), and together with SigmaCare, collectively, the "Grantors" and each, a "Grantor"), each with a chief executive office at 575 Eighth Avenue, 15th Floor New York, NY 10018

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of February 28, 2017, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by each Grantor to Grantee in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on March 1, 2017 at Reel 5999 and Frame 0959; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. Definitions. The term "Trademarks," as used herein, shall have the meaning set forth in the Security Agreement and shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges all liens and security interests in the Trademarks, including those identified on Schedule A effective as of the date hereof.
