RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of June 19, 2017 (the "Effective Date"), by NATIONAL BANK OF CANADA, as Secured Party (the "Secured Party"), in favor of the Grantors (as defined below). Capitalized terms used but not otherwise defined herein have the meanings given to them in the applicable Security Documents (as defined below), the Trademark Security Agreements (as defined below) or Credit Agreement (as defined in the Security Agreement), as applicable.

WHEREAS, pursuant to (i) that certain Collateral Agreement dated on or about April 24, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") between LUMENPULSE LIGHTING INC., a corporation constituted under the laws of Canada ("Lumenpulse") and the Secured Party, (ii) that certain Hypothec on the Universality of Movable Property, dated on or about April 13, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Hypothec"; and together with the Security Agreement, the "Security Documents") between Lumenpulse and the Secured Party and (iii) that certain General Security Agreement, dated as of March 10, 2016 between FLUXWERX ILLUMINATION INC., a corporation constituted under the laws of the province of British Columbia ("Fluxwerx"; and together with Lumenpulse, the "Grantors") and the Secured Party;

WHEREAS, the Grantors granted a lien on and security interest in the Trademark Collateral in favor of the Secured Party pursuant to (i) that certain Trademark Security Agreement, dated as of April 24, 2013 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time and (ii) that certain Trademark Security Agreement, dated as of March 10, 2016 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, each a "Trademark Security Agreement"; and collectively, the "Trademark Security Agreements"), for recordation with the United States Patent and Trademark Office (the "USPTO");

WHEREAS, the Trademark Security Agreements were recorded with the USPTO on (i) April 26, 2013 with the trademark assignment division at Reel 005014, Frame 0886 for Lumenpulse and (ii) March 31, 2016 at Reel 005762, Frame 0374 for Fluxwerx; and

WHEREAS, the Secured Party now desires to release its lien on and security interest in the Trademark Collateral, including the trademarks set forth on the attached Exhibit A.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party, hereby agrees as follows:

The Secured hereby terminates the Trademark Security Agreements, and hereby terminates and releases the security interest in the Trademark Collateral arising under the Security Documents and the Trademark Security Agreements.

If and to the extent the Secured Party has acquired any right, title or interest in, to or under any of the Trademark Collateral, it hereby irrevocably reassigns and retransfers all such right, title and interest to each Grantor.

This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereto.
